## **TERMS AND CONDITIONS**

1. The tenders should be submitted only in SEALED COVER. Open/unsealed tenders will be rejected submersible.
2. Earnest money, as shown is required to be deposited by way of DD (only) in favor of the Director, IIM, Jammu along with the sealed tender. Tender received without Earnest Money Deposit will not be considered in any case.
3. Separate Tenders along with separate D.D for each Lot contained in a separate envelop should be submitted and Lot No. should be visibly indicated on the (each) envelop.
4. The bidders should clearly quote as asked for, both in figures and in words exclusive of any taxes and duties. Any overwriting in rates or any change / alteration without attestation is liable to culminate in outright rejection of the tender. In case there is any error between the amount specified in figures and words, the higher of the two will be taken for consideration.
5. The amount equivalent to the Earnest Money Deposit /DD so attached with the tender shall be adjusted in the final payment to be made by the successful bidders, whereas the other bidder may get the EMD/DD back after finalizing of the auction formalities at our end.
6. The sealed tenders should reach the office of the undersigned accompanied by demand draft as earnest money latest by **03.08.2017 up to 03.00 PM.** which will be opened on the same day i.e. on **03.08.2017 at 3.30 PM.** in Presence of the bidders, if any.
7. The vehicles offered for condemn is on **“AS IS WHERE IS BASIS”**, IIM Jammu and IIM Srinagar branch. Taxes & duties, if any, Levi-able by the Govt., at the time of final payment, will be extra as applicable.
8. Vehicles can be inspected in the Central Stores of IIM, Canal Road, Jammu, and Branch IIM Srinagar, Sanat Nagar on any working day from **24.07.2017 to 28.07.2017 (3.00PM to 05.00PM).** The bidders should satisfy themselves in respect of condition, description & quantity of the lots before quoting their rates.
9. Condition of all Lots may particularly be seen. The successful tenderer shall have to lift the whole material of a lot allocated / awarded to him. No pick & choose will be allowed.
10. The labor, transport/crane & other arrangements will have to be made by the purchasers at their own cost, risk & responsibility.
11. The successful tenderer should deposits the remaining amount and lift the material within two - three days from the date of depositing the cost. In case the lot is not lifted within the time specified, ground rent as

decided by the committee per lot per day will be charged from the purchaser for a further period limited to **Five days, excluding holidays** and the material not so removed will be treated as abandoned lots and the EMD and other sums paid for the lot will be forfeited without any reference to the purchases. For such abandoned lots, the institute reserves the right to re-sale.

12. In case of any dispute in these transactions, the same shall be restricted to the Jurisdiction of courts at Jammu.
13. The Institute reserves the right of withdrawing from the sale of any material or lots at any stage without assigning any reason thereof.
14. All the prospective bidders are requested to submit the tender on their Letter Head Pad duly signed with seal on each page.
15. **These condemned vehicles are sold as a scrape without registration documents. In the event of buying of Vehicles for any personal or commercial purpose, the highest bidder in whose favour allotment is given will have to get the papers registered in his own name with transport authorities before lifting the Vehicles.**
