Subject:-Observation of Vigilance Awareness Period during the year 2020.

The participants for Debate & Essay writing competition for IIIM will be Staff & Research Fellows of CSIR-IIIM.

On conclusion day i.e., on 2nd Nov., 2020 a lecture on topic "Satark Bharat, Samridh Bharat (Vigilant India, Prosperous India)." will be given by Guest Faculty. Prize distribution to the winners of various competitions by the Director, IIIM and an online Valedictory address by the Er. Rajneesh Anand, Chief Scientist on 2nd Nov., 2020.
