**Stage (i)** There will be no element of interview for the selection of Technical Assistant posts. The selection for these posts in stage-I shall be through Trade/Skill Test. Hence, candidates qualifying Trade/Skill Test will have to undergo Written Test in stage-II.

**Stage (ii)** Through Written Test.

For these posts, there will be three papers. The Paper-II & Paper III will be evaluated only for those candidates who secure the minimum threshold marks (to be determined by the Selection Committee) in the Paper-I.

**II. General Benefits:**

1. These posts carry usual allowances i.e. Dearness Allowance (DA), House Rent Allowance (HRA) and Transport Allowance (TA) as admissible/applicable to CSIR/ Central Govt. employees posted at Jammu/Srinagar.
2. Council employees are also eligible for accommodation of their entitled type as per CSIR Residence Allotment Rules, depending on availability in which case HRA will not be admissible.
3. In addition to the pay level and pay matrix indicated against each category of posts, benefits such as reimbursement of Medical Expenses, Leave Travel Concession, Conveyance Advance, House Building Advance provisions etc. are applicable to CSIR employees.
4. If required, appointee can be deployed in any Lab. /Institute of CSIR located in other parts of India.
5. Council provides excellent opportunities to deserving candidates for career advancement under assessment promotion scheme for Technical Staff.

6. The posts will be governed by the New Pension Scheme (NPS) applicable with effect from 01.01.2004 as notified by the Government of India and adopted by CSIR and other instructions issued on the subject. However, persons selected from other Government Departments/Autonomous Bodies/Public Sector Undertakings/Central Universities having Pension Scheme on GOI pattern and who are presently being governed by old Pension Scheme will continue to be governed by the existing Pension Scheme i.e. CCS(Pension Rules), 1972.

### **III. AGE LIMIT & RELAXATIONS**

1. The prescribed date for determining the upper age limit/qualifications/experience etc. shall be the closing date for submission of applications.
2. The upper age limit is relaxable upto 05 (five) years for SC/ST and 03(three) years for OBC as per Government orders in force only in those cases where the posts are reserved for respective categories, on production of relevant certificate in the format prescribed by Govt. of India signed by the appropriate competent authority at the time of Trade /Skill Test.
3. As per GOI provisions, for Widows, Divorced Women and Women Judicially separated from their Husbands; the upper age limit is relaxable up to the age of 35 years (up to 40 years for members of Scheduled Castes/Scheduled Tribes and up to 38 years for members belonging to the Other Backward Classes in respect of the posts reserved for them). The persons claiming age relaxation under this sub-Para would be required to produce following documentary evidence:
  - (i) In case of Widow, Death Certificate of her husband together with the Affidavit that she has not remarried since.
  - (ii) In case of divorced Women and Women judicially separated from their husbands, a certified copy of the judgment/decree of the appropriate Court to prove the fact of divorce or the judicial separation, as the case may be, with an Affidavit in respect of divorced Women that they have not remarried since.
4. Upper age limit for Persons with Disabilities (PWD/Divyang) shall be relaxable by 10 Years for UR candidates, 13 years for OBC candidates and 15 years for SC/ST candidates. The persons claiming age relaxation under this sub-para would be required to produce a certificate in prescribed proforma in support of their claims clearly indicating that the degree of physical disability is 40% or more. In any case, the appointment of these candidates will be subject to their being found medically fit in accordance with the standards of medical fitness as prescribed by the Government for each individual posts to be filled by Direct Recruitment by Selection.
5. The upper age limit is relaxable upto 05 years for the regular employees working in CSIR Laboratories/Institutes/ Government Departments/Autonomous Bodies/Public Sector Undertakings.

6. Relaxation of five years will also be permissible to those who had ordinarily been domiciled in the state of Jammu and Kashmir during the period from 01.01.1980 to 31.12.1989 subject to production of relevant certificate from concerned authority.
7. Candidates belonging to the Scheduled Caste, Scheduled Tribe and Other Backward Classes who are also covered under any other clauses of sub para III(4) to III(6) above, viz. those coming under the category of Persons with Disabilities, Departmental Candidates, persons domiciled in the State of J&K will be eligible for grant of cumulative age relaxation under both the categories in respect of posts reserved for them.
8. Relaxation in age over and above the stipulated limit, educational qualification & experience may be considered in case of **exceptionally meritorious candidates** or **in case** if sufficient number of candidates possessing the requisite qualification/ experience are not available to fill up the posts.

#### **IV. GENERAL CONDITIONS/INFORMATION:-**

1. The applicant must be a citizen of India.
2. The prescribed essential qualifications are the minimum and the mere possession of the same does not entitle candidates to be called for Trade/Written Test. The decision of Director, CSIR-IIIM in all matters relating to eligibility, acceptance or rejection of applications, mode of selection, conduct of trade/written test will be final and binding on the candidates and no enquiry or correspondence will be entertained in this connection from any candidate.
3. The application should be accompanied by self-attested copies of the relevant educational qualification and experience certificates. The prescribed qualifications should have been obtained from recognized Universities/Institutions etc. Incomplete applications received and applications not accompanied with the required certificates/documents are liable to be rejected.
4. In respect of equivalent clause in Essential Qualifications, if a candidate is claiming a particular qualification as equivalent qualification as per the requirement of advertisement, then the candidate is required to produce order/ letter in this regard, indicating the Authority (with number and date) under which it has been so treated otherwise the Application is liable to be rejected.
5. The period of experience rendered by a candidate on part time basis, daily wages, visiting/ guest faculty will not be counted while calculating the valid experience for short listing the candidate for trade/written test.
6. The period of experience in a discipline/area of work, wherever prescribed, shall be counted after the date of acquiring the minimum educational qualifications prescribed for that post.

7. If any document/certificate furnished are in a language other than Hindi or English, a transcript of the same duly attested by a Gazetted officer or notary is to be submitted.
8. Canvassing in any form or bringing of any influence, political or otherwise, will be treated as a disqualification for the post.
9. Date of Trade/Written Test or any other updates as the case may be will be displayed on CSIR-IIIM website.
10. No TA will be reimbursed for attending the Trade/Written Test.
11. Applications from candidate working in Government Departments, Autonomous bodies and Public Sector Undertakings will be considered only if forwarded through proper channel, certified by the employer that the applicant will be relieved within **one month** of the receipt of the appointment orders, if selected. Vigilance clearance should also be recorded in such cases. However, advance copy of the application may be submitted before the closing date.
12. Any addendum/Modification/corrigendum shall be posted on our website only. All notifications regarding this advertisement will be displayed/uploaded on our website only from time to time.
13. Candidates applying for more than one post have to submit separate Application Form for each post indicating the Category and Post Code along with prescribed application fee and self attested copies of all marks cards, certificate and testimonials.
