- 1. Pickup and safe disposal of chemical waste from CSIR-IIIM, Jammu campus.
  - a. The categories for chemical waste to be disposed from IIIM, Jammu campus are as follows:

- Disposable Chemical includes used solvents and laboratory chemicals that are no longer required.
- IIIM will provide the disposable chemical in plastic/metal container.
- The vendor may be called to make up for around 4-5 trips in a month. The specific schedule will be communicated to the vendor
- •There is no guaranteed number of chemical wastes that must be disposed via the contract. The disposal is subject to availability.
- Collection/transportation of toxic/hazardous/non-hazardous/chemicals from the place designated for this purpose.
- After collection of the disposable chemicals from designated place, the contractor will be liable to package, label, transport, treat and dispose the material in accordance with all applicable union/state/local laws and regulations.
- Contractor may recycle, use, distribute or sell the disposable chemicals or their component or any residue thereof after picking up the disposable chemical from IIIM .The onus is on the contractor to use/dispose the material in the ambit of existing State/Union rules.
