- 5. Google Form submitted after the scheduled date and time i.e. 8th June 2023 (Thursday) up to 5:00 pm. shall not be entertained and summarily rejected.
- 6. The duly constituted Screening Committee shall screen the application and shortlist the candidates for Walk-in-Interview. The list of eligible shortlisted candidates, venue of interview and date for Interview will be displayed on CSIR-IIIM Website: www.iiim.res.in by evening on 13th June 2023 (Tuesday).
- 7. The shortlisted candidates are requested to be present at the venue of interview on the **date of Interview ONE HOUR BEFORE the scheduled time of Interview [i.e. Candidates are supposed to arrive at the venue of interview ON OR BEFORE 9:00AM.]** for necessary verification of documents. Candidates will not be entertained after 10.00 AM under any circumstance. (if any change is there, they will be accordingly intimated).

The shortlisted candidates are required to attend the Walk-in-Interview along with Original Certificates in support of Date of birth, Essential Educational Qualification, Category Certificate (if applicable) etc. Tentative Mark Sheets/Certificates and '**RESULT AWAITED'** will not be considered.

- 9. To avoid any inconvenience, only those candidates who strictly fulfil the eligibility criteria and possess the degrees/mark sheets in the aforesaid subjects should apply for online application through Google Form.
- 10. In case the final certificates reflect CGPA/SGPA/OGPA Grades etc., in that case, the candidate should convert the same into equivalent percentage as per the approved formula of the University in the Google Form and a copy of such conversion formula must be attached along with the Google Form.
