Prospective tenderers are advised to get register themselves at NIC CPPP portal, obtain 'Login ID' & 'password' and go through the instruction available in the Home Page after log into the CPPP-portal <http://etender.gov.in/e procure/app>. They should also obtain Digital Signature Certificate (DSC) in parallel which is essentially required for submission of their tender.

The tenderer shall submit their e-tender only at CPPP portal <https://tender.gov.in/e procure/app>. Tenderers/Contractors are advised to follow the instructions provided in the tender documents for online submission of bids. Tenderers are required to upload the digitally signed file of scanned documents alongwith scanned copy of bank receipt/ bank statement for depositing

of Tender Fee. Bid documents may be scanned with 100 dpi with black and white option which helps in reducing size of the scanned document. Uploading of tender in location other than specified above shall not be considered. Hard copy of tender shall not be entertained in that case.

**Earnest Money Deposit (EMD):** Earnest Money Deposit (EMD) of Rs.4000/- (Rs Four only) will be required to be paid in the form of Demand Draft/Banker's cheque from Scheduled/Nationalized Banks in favour of "The Director, CSIR-IIIM" payable at "Jammu" and the scanned copy of the same should be uploaded during the submission of Tender duly signed digitally. EMD must be valid for minimum 90 days from the date of publication of the tender. Since the bid is to be submitted online, the Original EMD should be sent by post to reach the office of the Sr.COA before bid submission end time. Tenders submitted without EMD and incomplete tenders will be summarily rejected. CSIR-IIIM will not be responsible for any postal delay. MSME/NSIC Registered firms shall be granted exemption for EMD only. The MSME units claiming exemption of EMD should enclose valid MSME/NSIC Registration certificate, otherwise they need to deposit EMD of Rs.4,000/- as mentioned above.

**1. Eligibility Criteria for bidders:**

a) Experience of having successfully completed similar works in **Central/State Govt./Autonomous Bodies/Public Sector Undertaking/ Govt. Institutions /CSIR Institutes/Laboratories** during the last seven years ending last day of month previous to the one in which bids are invited (30<sup>th</sup> April 2022) should be either of the following:-

i) **Three similar completed works each costing not less than Rs. 1.60 lakh**

or

ii) **Two similar completed works each costing not less than Rs. 1 lakh**

or

iii) **One similar completed work costing not less than Rs. 0.8 lakh**

**b) Definition of similar works:**

Similar works means, successful completion of "**Providing & fixing signages/signage work**" in any **Central/State Govt./Autonomous Bodies/Public Sector Undertaking/ Govt. Institutions /CSIR Institutes/Laboratories, completed on or before March 31, 2023.**

**2. Financial Capability:**

Average annual financial turnover of 'The Bidder' during the last three years, ending on 31.03.2023, should be at least **Rs. 2 Lakh** as per the balance sheet and profit & loss account of the relevant period.

**3. Procedure for submission of tender: -**

**The tenders are invited under Two Bid system.**

**3A.Technical Bid:**The technical Cover should include the following documents:

1. **The bidder must have at least three years experience (ending 31.03.2023) of providing similar nature of works as per eligibility criteria particularly “Providing & fixing signages/signage work in Central/State Govt./Autonomous Bodies/Public Sector Undertaking/ Govt. Institutions/Nationalised Banks/CSIR Institutes/Laboratories. Services rendered with list of such Central/State Govt./Autonomous Bodies/Public Sector Undertaking/ Govt. Institutions/ Nationalised Banks/ CSIR Institutes/Laboratories with duration of service shall be furnished.**
2. Experience in providing Similar services to Central/State Govt./Autonomous Bodies/Public Sector Undertaking/ Govt. Institutions/CSIR Institutes/Laboratories to the tune of at least Rs 1.6 Lakh (80%) per annum in a single contract or two works worth at least Rs 1 Lakh (50%) each in a year or three works worth at least Rs. 0.8 (40%) each in a year over the last five years ending March 31, 2023.
3. Registration Certificates from EPF/ESI authorities.
4. GST registration certificate and PAN Card.
5. The tenderer should have a fully functional local Office in the UT of Jammu and Kashmir, capable of dealing with issues relating to financial as well as administrative matters and bank account in a Nationalised Bank/Commercialised Bank having a Branch in the UT of Jammu and Kashmir. A team from IIIM Jammu will inspect the office before issue of award letter.
6. Income Tax returns filed for the last 3 years(2020-21, 2021-22, 2022-23)
7. Average annual financial turnover of related services during the last three years, ending 31-03-2023, should be atleast of Rs.3.68 crore (50% of the estimated cost).
8. Proof of depositing EMD in favour of Director, CSIR-IIIM, Jammu.

**3B. Cover-2:** Financial e-bid through CPP Portal:-

- a) Financial Bids of the tenderers who qualify in the technical bid shall be opened.
- b) Bidders are required to download the format, open it and complete the unprotected cells with their respective financial quotes and other details (such as name of the bidder). Once the details have been completed, the bidder should save it and submit online, without changing the file name.
- c) Rates along with Total Amount (inclusive of GST) are required to be quoted in the BOQ.
- d) L1 will be decided by the lowest Rates quoted by the CONTRACTOR. In case Rates quoted by two or more agencies are equal, L1 will be decided by considering the total contract amount of all the completed valid works executed by the CONTRACTOR during the last five financial years and the CONTRACTOR having highest total contract amount as furnished in Annexure II, will be considered as L-1 for the purpose of award of work.
- e) Tenderer must ensure that all the uploaded documents should be of good quality. Vague/poor quality of printed documents and incomplete document will not be accepted.

The Director, CSIR-IIIM, Jammu reserves the right of accepting or rejecting any or all tenders or any part thereof without assigning any reason.

**4. Bid Validity:**

90 days from the date of opening of the bids/tender (Technical Bids).

**5. Evaluation of Tenders:**

- a. Technical Bids will be evaluated by CSIR-IIIM, Jammu based on the documentary evidence submitted by the bidder as per the Eligibility Criteria and other technical Parameters
- b. (i) The bids not accompanied with EMD, similar work experience certificate, as per the tender conditions shall be treated as non-responsive and ineligible.  
(ii) The bids not accompanied with financial documents as per **Technical Bid** of the tender shall be treated as non-responsive and ineligible.
- c. During evaluation of bids, CSIR-IIIM, Jammu at its sole discretion may seek clarification from the bidder (s), if any, in their bid and the bidder is required to respond within the stipulated time

period, failing which CSIR-IIIM, Jammu will take suitable decision in this regard.

**6. Right to accept any tender and to reject any or all tender:**

Director CSIR-IIIM, Jammu, reserves the right to accept or reject any tender, and or to annul the bidding process and or reject all tenders at any time prior to award of contract, without thereby incurring any liability to the affected bidder or bidders or any obligation to inform the affected bidder or bidders of the grounds for CSIR-IIIM, Jammu's action.

**7. Time of Completion:**

- i) The work shall be completed in all respects within **1 (One) month** from the date of issue of work order.
- ii) Due to an event, not attributable to the contractor, causing delay occurs or a variation order is issued, which makes it impossible to complete the work by scheduled completion date, CSIR-IIIM, Jammu may consider extending the completion date on request of the contractor.

**iii) If CSIR instructs to hold the work for brief period of one or two days for inspection & visit of the experts etc., the grace period will be given for such period in overall completion period of the work.**

**8. Liquidated Damages/ Penalty for Delay:**

If the contractor fails to complete the work within the stipulated time or time extended by the Institute (if any), liquidated damages at the rate of 1% per week subject to maximum 10% of the total work value shall be deducted/ recovered from the contractor.

**9. Specifications:**

The Contractor must confirm before supply that the name signages/stickers/other type signages supplied by them are as per specification of goods mentioned in the tender and in case of any variation; the contractor shall be liable to replace the same. The Security cum Performance Guarantee will be forfeited if replacement is not done as per direction of CSIR-IIIM.

**10. (A) Award of Contract:**

- (i) CSIR will notify the successful bidder that his tender has been accepted and work order will be sent to the bidder describing the works to be carried out and the same shall be returned duly acknowledged affirmatively by the bidder as a token of acceptance and the work shall be started immediately after receipt of the work order.

**(B) Foreclosure of contract due to abandonment or reduction in scope of work** - If at any time after acceptance of the tender, CSIR-IIIM, Jammu decides to abandon or reduce the scope of the work for any reason, whatsoever, and does not require the whole or any part of the work to be carried out, the Institute shall give one month's notice in writing to that effect to the contractor and the contractor shall act accordingly in the matter. The contractor shall have no claim to any payment of compensation or otherwise, whatsoever, on account of any profit or advantage which he might have derived from the execution of the work in full but for the foreclosure of the work.

- (i) Subletting - The contractor shall not assign or sublet the work.

**11. Performance Security:**

**On award of the contract, the firm will be required to deposit an amount equivalent to 10% of the contract value as Security Deposit / Performance Guarantee in the form of Demand Draft / Fixed Deposit from Scheduled**

Commercial Banks in favour of “The Director, IIIM, Jammu” payable at Jammu which will be retained by the Authority for the due and faithful fulfilment of the contract. The S.D / P.G should remain valid for a period of 60 days beyond the date of completion of all contractual obligations by the firm. No interest shall be payable by the Authority on the amount of S.D / P.G so held. The Authority reserves the right to forfeit fully or partly the Performance Guarantee in the event of failure on the part of the contractor to execute the contract or observations of all or any of the terms & conditions. The decision of Director, CSIR-IIIM, Jammu in this regard shall be final & binding. In case the contract is further extended beyond the initial period, the Performance Guarantee will have to be accordingly renewed/extended by the successful tender(s).

**12. Signing of Contract Agreement:**

Upon receipt of the performance security, a Contract Agreement will be entered into by both the parties. The contract agreement form is enclosed at APPENDIX-B. The contractor will present a signed copy of the same to CSIR-IIIM on stamp paper of appropriate value.

**13. Payment:**

- (i) Payment will be made after completion of the whole works. The contractor will submit the bill and payment shall be made within 30 (thirty) days from receipt of the bill. TDS will be deducted from the amount payable to the contractor. No advance payment shall be made to the contractor. The contractor will be required to raise Invoice/Bill as per GST Rule and GST amount should be shown properly in the invoice.
- (ii) Necessary Bank details need to be provided for release of payment directly in bidder’s Bank Account. Bank Details is to filled in the column by bidder as given below:

## 19 Bill of Quantity:

The quantities of signages given in the Bill of Quantities (BOQ) are approximate to give an idea of work. Work will be carried out as per the given scope, requirement of CSIR-IIIM and design of signages during execution at site. The quantities may vary 25% on higher or lower side. The contractor will execute the varied quantity of work on the quoted rates. Payment will be made as per actual quantity of work done at site.

20 a) **Designing of Signages:** The agency will design each signage to have uniformity of font size, style as per available space and site condition.

b) **Tool & Tackles:** All tools, tackles will be arranged by the contractor and their charges will be deemed to be included in the quoted rates, no extra payment shall be made for the same. **Site covering and cleaning etc. charges shall be deemed to be included in the quoted item rates.**

c) **Water & Electricity:** Water & Electricity will be provided free of cost by CSIR-IIIM, at one point near the work place from where the contractor will make arrangement of pipes, cables, power plugs, sockets etc. to extend the same to the work place.

### 21. Resolution of Dispute:

**In the event of any dispute or difference arising out of or in any way touching or concerning this agreement whatsoever the same shall be referred to Delhi International Arbitration Centre (DIAC) set up under Arbitration and Conciliation (Amendment) Act, 2015 whose decision thereon shall be final and binding on the parties thereto.**

### 22. Force Majeure:

22.1 Notwithstanding the provisions stated above, the service provider shall not be liable for forfeiture of its performance security, penalty or termination for default, if and to the extent that, its delay in performance or other failure to perform its obligations under the contract is the result of an event of force majeure.

22.2 For purpose of this clause "Force Majeure" means an event beyond the control of the service provider and not involving the contractor/service provider's fault or negligence and not foreseeable. Such events may include, but are not limited to acts or the service provider either in its sovereign or contractual capacity, war or revolutions, fires, floods, epidemics, quarantine restrictions and freight embargoes.

22.3 If a force Majeure situation arises, the contractor/service provider shall promptly notify the CSIR-IIIM in writing of such conditions and the cause thereof. Unless otherwise directed by the employer in writing, the service provider shall continue to perform its obligations under the contract as far as is reasonably practical, and shall seek all reasonable alternative means for performance not prevented by the force majeure event.

### 23. SCOPE OF WORK:

1. Bilingual signages for laboratories names & other facilities etc. are to be designed, printed on vinyl sheet and pasted on door frames, door shutters and other hard & flat surfaces as per the available space and site conditions.

**The signage design shall be kept uniform as far as possible and shall be got approved from CSIR-IIIM before printing.**

2. Signages for those locations/places where vinyl sticker signages cannot be pasted directly the same shall be pasted on 3mm thick ACP sheet and fixed to the wall or hanged from the ceiling etc. with studs/double tape/ aluminum hook & chains as per site conditions/location.
3. Vinyl letters in blue back ground and white letters shall be pasted on 4mm thick clear acrylic sheet for name plates. Name plates will be fixed to the wall with stainless steel studs/double tape etc.

**The agency will design and show the signage to CSIR-IIIM before printing. Sample of each type of signage shall be got approved from CSIR-IIIM before making bulk quantity as per order.**

4. Existing vinyl stickers will be removed before putting new signage in its place.
