ONLINE SELECTION PROCEDURE

1. Application for the position can be filled out online at Google Forms link:

2. The filled-up Google Form should be submitted by or before **10th April 2024 (Wednesday) up to 5:00 PM**. Application Forms after the scheduled date and time shall not be entertained for the interview.

3. Only eligible candidates shall be accessed for the viva voce on the date of the interview.

4. All applicants/candidates will be required to send a recommendation letter forwarded/endorsed by the head of the institute/department where they are currently studying through email to rashmi.sharma.09@iiim.res.in, by or before **12th April 2024 (Friday)**. After verification of the documents, final list of eligible candidates will be displayed on CSIR-IIIM website www.iiim.res.in on **15th April 2024 (Monday)**.

5. Eligible/shortlisted candidates shall attend the interview online through video conference on **MS Teams**. The shortlisted candidates shall have to be available on the date of the Online Interview, i.e. **22nd April 2024 (Monday)**, from **9:30 AM onwards** and will be called anytime during the allotted time (if any change is there, they will be intimated accordingly).

6. In case a large number of candidates apply, the Screening Committee may re-visit the screening criteria and shortlist the candidates for interview in proportion to the available vacancies.
7. Candidate has the option to interact in English/Hindi before the Selection Committee.
8. To avoid any inconvenience, only those candidates who strictly fulfill the eligibility criteria and possess the degrees/mark sheets in the subjects above should apply for the interview.
