INVITATION FOR EXPRESSION OF INTEREST

- Director, Indian Institute of Integrative Medicine, Canal Road, Jammu-180001, invites Expression of Interest (EDI) from Indian manufacturers/distributers and Indian agents of foreign parties for supply, installation and commissioning of Fermentation Pilot Plant (fermenters 15L/200L/1000L and 5000L and supporting downstream processing facility) along with compatible utility.
- 2. Full technical details along with complete reference list, phone no and emails of quoted equipments must be submitted with the office of Stores and Purchase Officer, CSIR-IIIM Jammu on or before **<u>21.06.2024</u>**.
- 3. An EOI conference will be arranged on <u>25.06.2024</u> at <u>03:00 pm</u> in the **Conference Hall** of the institute. All the prospective bidders are invited to make presentation followed by discussion on specifications, design, utility, spares client list and credentials and post warranty services.
- 4. Only those bidders are eligible to participate in the EOI, who have at least 10 years of experience in manufacturing of fermenters, have local service support in India and two or more pilot plant installations in Govt. Organizations in India. Documentary evidence should be provided.
- 5. Bidders may visit the site before EOI conference.
- 6. Bidder/supplier to submit documentary evidence like certificate from a least three users working in Biochemical Engineering/Fermentation related work for the same equipment from government or semi government research organization/Institutions/industries to the effect that they are satisfied with the performance of the equipment and service of the supplier over past five years.
- 7. Manufacturer should have ISO 9001-2015 Certification.
- 8. All the pressure vessels should be certified by NABL Accredited Third party inspection agency.
- 9. The tender should follow the ASME BPE norms.
- 10. The vendor should be capable to take the project as a whole and execute and interface the various equipments.
- 11. Interested bidders can obtain further information from the office of Stores and Purchase officer, CSIR-IIIM, Jammu, India.
- 12. The Director, IIIM Jammu reserves the right to accept or reject any for all EOI either in part or in full without assigning any reason thereof.

1. List of activities proposed to be carried out by the bidder/supplier

- Design of Fermentation Pilot plant layout based on the site
- Design, fabrication and installation and commissioning of fermenters (ISL/200L/1000L/5000L), storage vessel(s), dose vessel etc. based on the desired specifications along with supporting utility including boiler, air compressors other required utilities
- Supply, installation and commissioning of supporting downstream processing inline equipments (such as centrifuges and other equipments).
- Bidder should indemnify CSIR-IIIM for any harm liability and causality.
- 2. Interested parties meeting the eligibility criteria are requested to fill up annexure A appended at the end of the document and submit in CSIR-IIIM.
- All interested parties are requested to submit their EOI. The last date for submission of EOI is <u>21.06.2024</u>. The EOI will be opened on <u>21.06.2024 at 04:00 pm.</u> The Subsequent amendment / changes if any will be published in our website also.
- 4. CSIR-IIIM, may, at its discretion, extend this deadline for submission of EOI by amending the Bid Documents or any other reasons, in which case all rights and obligations of the CSIR-IIIM and Bidders previously subject to the deadline will thereafter be subject to the deadline as extended.
- 5. Bid Submission method: Interested parties are requested to fill up all the Annexure enclosed and submit the bid with all the necessary supporting documents. The EOI shall be submitted **online** on or before **21.06.2024**
- 6. EOI will be opened in the presence of bidder's representative(s) who choose to attend on the specified date and time, at the office of CSIR-IIIM at the address given.
- 7. In the event of the date specified for bid receipt and opening being declared as a closed holiday for CSIR-IIIM, the due date for submission of EOI and opening of EOI will be the following working day at the specified times as given above.
- 8. CSIR-IIIM will not be held responsible for delay, if any, in the submission of the bidding document or the non-receipt of the same. EOI sent by Telex/Fax/Telegraph will not be accepted.
- 9. Evaluation: The evaluation will be carried out by a Technical committee constituted by the competent authority of CSIR-IIIM. CSIR-IIIM may decide not to continue with the empanelment and cancel the notice of inviting EOI either full or in part at its discretion. The committee shall check the documents attached to the tender as asked for in the qualification requirement. The committee may ask the parties to come for a discussion/presentation if required. All the parties who meet the requirements of the tender shall be shortlisted for the activities.
- 10. Director CSIR-IIIM reserves the right to reject any or all bids either in part of in full without assigning any reason.
- 11. Arbitration: Any dispute arising out of this Agreement, the same shall be referred to the arbitration of 3 (three) arbitrators, one to be appointed by each party to the dispute, and the third and presiding arbitrator shall be nominated by the said two arbitrators before entering into any reference. The decision of the majority of arbitrators shall be final and binding on both parties. The venue of arbitration shall be at Jammu and the arbitration proceedings shall take place under the provisions of Indian Arbitration and Conciliation Act, 1996.
