INVITATION TO BID

Sub: Quotation for supply, Testing and Commission of “REFRIGERATED CENTRIFUGE.”

Ref: Our Enquiry No. 06(14)/2024-P dated: 24.09.2024

Director, CSIR – Indian Institute of Integrative Medicine herein after called as the ‘**Purchaser**’ is interested in the procurement of **Refrigerated Centrifuge**. The supply, Installation, Testing and Commissioning of the instrument as required at the site **CSIR-Indian Institute of Integrative Medicine, Canal road, Jammu-180001**. The interested bidders are requested to kindly submit their bids accordingly. The detailed specifications are mentioned below:

Specification of Refrigerated Centrifuge

- Multipurpose bench-top centrifuge with 1 liter capacity or better.
- Temperature range -9 °C to 40 °C, or better.
- Centrifuge should have an RCF of 20,000xg, or better.
- System should be capable of using fixed angle and swing out rotors with adapter to use different tube formats.
- System should have a capacity of 4 x 250 ml, 15 ml, and 50 ml rotor, or better.
- The RCF for fixed angle and swing out rotors should be 20,000xg force and 4,500xg force respectively or better.
- System should have LCD display, user-friendly operation; key panel with provision to set speed RPM / RCF, or better.
- System must be equipped with automatic rotor recognition and imbalance detection for maximum operational safety.
- Timer setting 1 min to 99 min, with continuous run function and separate short spin key with selectable rotational speed, or better.
- System should have 10 acceleration and deceleration steps.

- Noise level at max speed should be less than 58 dB(A) for quiet operation in work place.
- Rotors and rotor lids should be fully autoclavable at 121°C.
- Features in the quotations should be substantiated with proper company catalogue.
- System must be European CE or UL 61010 or DIN or ISO certified, or better.
- Warranty of at least one year from the date of successful installation in the lab.

Rotors to be supplied

- Rotor along with rotor lid with RCF 15,000× g and speed 11,000 rpm with a capacity to hold 6 × 85 mL, 6 × 50mL, and 6× 15mL tubes with adapters. Otherwise, a rotor with better capacity and speed should be provided.
- Rotor, lid, and adapters should be autoclavable.

Important Note:

1. **Price:** Prices Should be quoted FOR CSIR-IIIM, Canal Road, Jammu
2. **EMD:** An Earnest Money deposit of Rs.40,000/- (Rs. Forty thousands only) is mandatory to participate in this bid, failing which may subject to rejection of the bid. Bidder has to upload scanned copy / proof of the EMD along with the bid and has to ensure delivery of hardcopy to the Buyer within 5 days of Bid End date/Bid opening date(if EMD is in the form of FDR/DD).
3. **EMD Exemption:** The bidder seeking EMD exemption must submit the valid supporting document for the relevant category as per GeM GTC with the bid. Under MSE category only manufacturers for Goods and Service providers for Services are eligible from exemption from EMD. Traders are excluded from the purview of this policy.
4. **Standard forms:** It is mandatory to submit standard forms as per annexure I to annexure VII (format attached below) along with the technical bid.
