- 2. The filled-in Google Form should be submitted by or before 13<sup>th</sup> December 2024 (Friday) up to 05:00 PM. Google/Application Forms submitted after the scheduled date and time shall not be entertained for the interview and summarily rejected.
- 3. All applicants/candidates will be required to upload in the Google Form a recommendation letter forwarded/endorsed by the Head of the Institution/Department where they are currently studying.
- 4. Only eligible candidates shall be accessed for the interview. The list of eligible candidates and the date for the interview will be displayed on the CSIR-IIIM Website, <u>www.iiim.res.in</u>, by the evening on 17<sup>th</sup> December 2024 (Tuesday). Eligible/shortlisted candidates shall attend the interview on MS Teams.
- 5. In case a large number of candidates apply, the Screening Committee may re-visit the screening criteria and shortlist the candidates for interview in proportion to the available vacancies.
- 6. Candidate has the option to interact in English/Hindi before the Selection Committee.
- 7. To avoid any inconvenience, only those candidates who strictly fulfil the eligibility criteria should apply.
- 8. Upon selection/empanelment, the original documents will be verified; if any discrepancy is found, the selection/empanelment shall stand cancelled.
