- 1) FOR: Prices should be quoted FOR, CSIR-IIIM, branch Lab, Sanat Nagar, Srinagar.
- 2) EMD: An Earnest Money deposit of Rs. 50,000/- (Rs. Fifty thousands only) is mandatory to participate in this bid, failing which may subject to rejection of the bid. Bidder has to upload scanned copy / proof of the EMD along with the bid and has to ensure delivery of hardcopy to the Buyer within 5 days of Bid End date/Bid opening date.
- 3) EMD Exemption: The bidder seeking EMD exemption must submit the valid supporting document for the relevant category as per GeM GTC with the bid. Under MSE category only manufacturers for Goods and Service providers for Services are eligible from exemption from EMD. Traders are excluded from the purview of this policy.
