1.	Honey Bee boxes with colonies	<ol style="list-style-type: none">1. The bee hive should be langstroth.2. The bee hive for <i>A. Mellifera</i> should include 09 frames with 06 brood chambers, along with bottom board, Top cover, queen excluder in top, one queen gate and hive stand (four footed iron).3. The entire bee hive along with frames of brood chambers and supers should be made of Toon wood/Kali wood with fine finishing. The outer surface of the hive should be painted white/green colour with double layer locating and only well seasoned wood should be used in the bee box.4. The top cover should be hut type for protection from rain etc.5. The iron stand should be painted with rubber paint and with four ant wells in each pillar.6. The front side (at the top) of the bee hive/box should be labelled CSIR-Floriculture Mission along with CSIR-logo at the left side and CSIR-IIIM logo at the right side.7. - 1) **FOR: Prices should be quoted FOR, CSIR-IIIM, branch Lab, Sanat Nagar, Srinagar.**
- 2) **EMD:** An Earnest Money deposit of Rs. 50,000/- (Rs. Fifty thousands only) is mandatory to participate in this bid, failing which may subject to rejection of the bid. Bidder has to upload scanned copy / proof of the EMD along with the bid and has to ensure delivery of hardcopy to the Buyer within 5 days of Bid End date/Bid opening date.
- 3) **EMD Exemption:** The bidder seeking EMD exemption must submit the valid supporting document for the relevant category as per GeM GTC with the bid. Under MSE category only manufacturers for Goods and Service providers for Services are eligible from exemption from EMD. Traders are excluded from the purview of this policy.
- 4) **Standard forms:** It is mandatory to submit standard forms as per annexure I to annexure VII (format attached below) along with the technical bid.
