IMPORTANT INSTRUCTIONS:

- 1. The position is purely temporary and co-terminus with the project. The engagement shall be initially for a period of **ONE YEAR** or till the project duration, whichever is earlier. The engagement shall be extendable on yearly basis subject to performance review and project duration. The duration of the project upto **20.01. 2028**.
- 2. The engagement of a project staff in different projects either in the CSIR Indian Institute of Integrative Medicine, Jammu or different Lab./Instt. of CSIR taken together shall not exceed 6 years in any case. It would, therefore, not confer any right/claim, implicit or explicit, for any candidate for claiming extension or absorption in CSIR-IIIM, Jammu.
- 3. Age will be reckoned as on the date of the Interview. Age relaxation for SC/ST/OBC/PWD candidates as per GOI/CSIR Instructions subject to production of certificates in prescribed format.
- 4. Age relaxation for Widows, Divorced Women, and Women Judicially separated from Husbands who have not remarried since, as per GOI/ CSIR provisions.
- 5. The filled-in Google Form should be submitted by or before 29th of May2025 (Thursday) up to 05:30 PM. Google/Application Forms submitted after the scheduled date and time shall not be entertained for the interview and summarily rejected.
- 6. Only eligible candidates shall be accessed for the interview. The list of eligible candidates and the date for the interview will be displayed on the CSIR-IIIM Website, <u>www.iiim.res.in</u>, by the evening on 2nd of June 2025 (Monday). Eligible/shortlisted candidates shall attend the interview on <u>MS Teams</u>.
- 7. In case a large number of candidates apply, the Screening Committee may re-visit the screening criteria and shortlist the candidates for interview in proportion to the available vacancies.
- 8. All short-listed candidates will be required to send scanned copies of following certificates, by 5:30 pm on or before 05th of June 2025 (Monday), through email at dryknalli@gmail.com. Please clearly mention your Name, Post-Code and Advt No., in the subject line of the email. - 11. To avoid any inconvenience, only those candidates who strictly fulfil the eligibility criteria and possess the degrees/mark sheets in the subjects above should apply for the interview.
- 12. Upon selection/empanelment, the original documents, including eligibility qualification, DOB, caste, and age relaxation certificate, will be verified; if any discrepancy is found, the selection/empanelment shall stand cancelled.
