# Sub.: <u>Corrigendum to Screening Result Lists Published on 21.06.2025 for the Posts of Junior Secretariat Assistant (Gen./F&A/S&P) and Junior Stenographer – Reg.</u>

The result of screening of applications for the posts of Junior Secretariat Assistant (Gen./F&A/S&P) and Junior Stenographer under Advt. Nos. 01R/2025 and 03R/2025 was published on the Institute's website on 21.06.2025. Subsequent to the publication, several representations were received from candidates, many of which pertained to rejection due to non-fulfilment of mandatory terms and conditions as stipulated in the respective advertisements.

Upon scrutiny, the following three representations were found to have merit, and accordingly, the screening result is partially modified as under:

#### 1) Post Code: ISA-01

- a) The name of the candidate at Sl. No. 1149 in the list of screened-out candidates (Reg. No. IIIM25JSA359281) is deleted from the rejected list and included at Sl. No. 207 in the list of provisionally screened-in candidates, subject to the condition that in the event of selection, the candidate shall be treated as a fresh candidate and no benefits of his previous service shall be carried forward.
- b) The application numbers of candidates at Sl. No. 281 (Reg. No. IIIM25JSA802578) in the screened-in list and Sl. No. 937 (Reg. No. IIIM25JSA269374) in the screened-out list are interchanged, based on verification of received applications.

### 2) Post Code: ISTENO-04

a) The name of the candidate at Sl. No. 129 in the screened-out list (Reg. No. IIIM25JST338998) is deleted from the list of rejected candidates and included at Sl. No. 128 in the list of screened-in candidates, as the candidate's application was found to have been received within the stipulated timeline but was inadvertently overlooked during initial screening.

Additionally, the candidate appearing at Sl. No. 323 (Reg. No. IIIM25JSA833212) in the list of screened in candidates for the post code JSA-01 is debarred from the examination for attempting to influence the recruitment process through corrupt means.
