General Terms, Conditions & Instructions:

- 1. The engagement will initially be for a period of **ONE YEAR** or until the project duration, whichever is earlier. It may be extended or curtailed depending on the project requirements and the performance/conduct of the incumbent(s). The current project duration is up to **31.03.2028**.
- The tenure of engagement shall be co-terminus with the project. However, under no circumstances shall the total tenure exceed six years, including engagement in all CSIR labs. Performance will be reviewed periodically and unsatisfactory performance may lead to termination without any notice or reason.

- 3. The position(s) are purely temporary and are on behalf of the sponsor and, therefore, not confer any right on the incumbent(s) to any claim, implicit or explicit, for absorption on any post in CSIR-IIIM/CSIR.
- 4. Candidates will have the option to interact in English/Hindi before the Selection Committee.
- 5. Relaxation in age limit will be given as per Govt. of India Rules. Age will be reckoned as on the date of the Interview.
- 6. In case the final certificates reflect CGPA/SGPA/OGPA Grades, the candidates should convert the same into an equivalent percentage as per the approved formula of the University in the Google Form, and a copy of such conversion must be uploaded on the Google form.
