- The engagement will initially be for a period of one year or until the project duration, whichever is earlier. It may be extended or curtailed depending on the project requirements and the performance/conduct of the incumbent(s). The current duration of the project is up to **31.03.2026**.

Performance will be reviewed periodically and unsatisfactory performance may lead to termination without any notice or reason.

4. Candidates will have the option to interact in English/Hindi before the Selection Committee.
5. Relaxation in age limit will be given as per Govt. of India Rules. Age will be reckoned as on the date of the Interview.
