- The engagement will initially be for a period of one year or until the project duration, whichever is earlier. It may be extended or curtailed depending on the project duration, requirements and the performance/conduct of the incumbent(s). The current duration of the project is upto **31.03.2027**.
- The tenure of engagement shall be co-terminus with the project. However, under no circumstances shall the total tenure exceed six years, including engagement in all CSIR labs. Performance will be reviewed periodically and unsatisfactory performance may lead to termination without any notice or reason.

- Candidates will have the option to interact in English/Hindi before the Selection Committee.
