

सूचना: विज्ञापन सं. 02R/2025 का छंटनी (स्क्रीनिंग) परिणाम

इस संस्थान के विज्ञापन संख्या 02R/2025 दिनांक 24.01.2025 के संदर्भ में, वैज्ञानिक पदों के लिए प्राप्त आवेदनों की जांच/स्क्रीनिंग हेतु प्रत्येक पोस्ट कोड के लिए CSIR Scientists Recruitment & Assessment Promotion Rules (CSRAP), 2001 के नियम 6.5.2 के तहत स्क्रीनिंग समितियाँ गठित की गई थीं।

गठित स्क्रीनिंग समितियों ने प्रत्येक आवेदन पत्र तथा उम्मीदवारों द्वारा अपलोड/प्रस्तुत किए गए सहायक दस्तावेज - जैसे जन्म तिथि, शैक्षणिक योग्यता तथा अनुसंधान/कार्य अनुभव से संबंधित प्रमाणपत्र - का परीक्षण किया।

प्रत्येक पोस्ट कोड (पोस्ट कोड S-1 से S-11 तक) के विरुद्ध प्राप्त आवेदनों की संख्या को ध्यान में रखते हुए, स्क्रीनिंग समितियों ने उम्मीदवारों को साक्षात्कार के लिए शॉर्टलिस्ट करने हेतु पोस्ट-कोड-वार स्क्रीनिंग मापदंड अपनाए। समितियों द्वारा अपनाए गए स्क्रीनिंग मापदंड, साक्षात्कार हेतु अस्थायी रूप से शॉर्टलिस्ट किए गए उम्मीदवारों की सूची तथा गैर-शॉर्टलिस्टेड/स्क्रीन-आउट उम्मीदवारों की सूची **अनुलग्नक-1** में संलग्न है।

With reference to this Institute's Advertisement No. 02R/2025 dated 24.01.2025, Screening Committees were constituted for each Post Code under Rule 6.5.2 of the CSIR Scientists Recruitment & Assessment Promotion Rules (CSRAP), 2001, to examine the applications received for the posts of Scientist.
